The Prudential Insurance Company of America ("Prudential") owns 100% of equity interests of Jennison. Jennison does not file jointly with Prudential, as such, shares of the Issuer's Common Stock reported on Jennison's 13G may be included in the shares reported on the 13G filed by Prudential.
