The options will vest only in the event that 2013 performance targets approved by the Board of Directors are met. If such targets are met, one-quarter of the options will vest in 2014, one-quarter will vest on February 1, 2015,

one-quarter will vest on February 1, 2016 and one-quarter will vest on February 1, 2017.
