- (1) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 1,173 units were acquired at prices ranging from \$36.85 to \$48.76. These transactions are exempt under rule 16a-11 and rule 16a-3(f).
- (2) During the fiscal year under a broker administered distribution reinvestment plan, 281 units were acquired at prices ranging from \$39.06 to \$48.76. These transactions are exempt under rule 16a-11 and rule 16a-3(f).
- (3) During the fiscal year under the Cedar Fair, L.P. Distribution Reinvestment and Employee Unit Purchase Plan, 88 units were acquired at prices ranging from \$39.06 to \$48.76. These transactions are exempt under rule 16a-11 and rule 16a-3(f).
