In accordance with the shareholder remuneration policy approved by Telefonica' s Board of Directors, at its meeting of July 23<sup>rd</sup>, 2003, Telefonica' s Board of Directors, at its meeting held today January 26<sup>th</sup>, has agreed the payment of a dividend of 0.5 Euro per share for fiscal year 2004 charged against both earnings and reserves.
