(1) These options were granted on 11/7/2003 and vest ratably over a four year period beginning 11/7/2004. 9,000 of these options were exercisable prior to the transactions reported on this Form 4.

(2) On September 15, 2005, a two-for-one stock split of the Common Stock of Silgan Holdings Inc. in the form of a stock dividend was effected, resulting in the reporting person holding an additional 18,900 nonqualified options to purchase common stock prior to the transactions reported on this Form 4. This amount includes 16,800 options granted on 2/4/2000 (all of which are currently exercisable) and 18,000 options granted on 11/7/2003 (6,000 of which are currently exercisable).
