- (1) per share and the remaining 10% at \$7.2246 (based on the average daily closing price of the Issuer's common stock on the NYSE for any 20 consecutive trading days preceding a vesting date), with pro rata vesting based on sustained improvement in the trading price of the Issuer's common stock between the exercise price and \$3.1548 and between the other stock price vesting thresholds set forth above.
- (2) Option vesting: 25% on the first anniversary of the grant date and in equal monthly installments during the three-year period thereafter.
