**Item 1.01 Entry into a Material Definitive Agreement.**

On August 7, 2008, Celebrity Solstice Inc. (“Borrower”), a subsidiary of Royal Caribbean Cruises Ltd. (the “Company”), entered into a Credit Agreement with KfW IPEX-Bank GmbH, as agent for Euler Hermes Kreditversicherungs AG and administrative agent, and KfW IPEX-Bank GmbH and BNP Paribas S.A., as lenders. The agreement provides for the making of an unsecured term loan not to exceed the US Dollar equivalent corresponding to Euro 412 million to the Borrower due through 2020, which when drawn will be guaranteed by the Company. The interest will be at a floating interest rate of LIBOR plus the then applicable margin or, if the Company so elects, all or a portion of the loan may be subject to a fixed interest rate (inclusive of the applicable margin). The Company intends to use the proceeds of the loan towards the purchase of *Celebrity Solstice*. A copy of the Credit Agreement is attached as Exhibit 10.1 to this Current Report on Form 8-K and is incorporated herein by reference.
