- Jeffrey A. Robins holds the shares of common stock of GLG Partners, Inc. ("GLG") solely in its capacity as trustee of the Roman GLG Trust, a trust established for the benefit of Emmanuel Roman and his family. Mr. Robins does not have any pecuniary interest in these shares. On November 6, 2007, Mr. Robins, in his capacity as trustee of the Roman GLG Trust, filed an initial statement of beneficial ownership on Form 3 with respect to the shares of common stock of GLG held on behalf of the Roman GLG Trust. This amendment to the original Form 3 adds the Roman GLG Trust as an additional reporting person. There has been no change in the shares held on behalf of the Roman GLG Trust by Mr. Robins, in his capacity as trustee of the Roman GLG Trust, and the holdings of shares are being re-reported solely to gain access to the EDGAR system.
