(1) On April 12, 2006, Mr. Ward entered into a collar transaction in relation to 1,000,000 shares of Common Stock. The exercise price of the put option is \$26.56 and the exercise price of the call option is \$40.20. Both options will expire on April 12, 2007, at which time the in-the-money option may be exercised. Mr. Ward has agreed to disgorge to the company any short swing profits resulting from this transaction.
