Note 1: All of these shares are subject to a two-year trading restriction which will expire 12/21/03.

Note 2: IDS common stock has been escrowed by former significant Petrocon Engineering, Inc. shareholders into an option pool reserve for the future redemption of these options.

Note 3: The option is exercisable in 1/4 increments on 11/1/00, 10/31/01, 10/31/02, and 10/31/03, respectively.

Note 4: The option is exercisable in equal increments annually over 10-year period beginning 9/16/97.

Note 5: Grant issued by Alliance 2000 Ltd., a significant IDS stockholder, to reporting person giving option to purchase shares of Common Stock held by Alliance. The option becomes vested and is exercisable only upon the sale of the Company.

Note 6: The exercise price of the Alliance 2000 Ltd option ranges from \$0.75 to \$1.25 over a five-year period as follows:
