- (1) On May 29, 2017, the Issuer entered into an Agreement and Plan of Merger with Ensco PLC ("Parent") and Echo Merger Sub LLC (the "Merger Agreement"). Pursuant to the Merger Agreement, on October 6, 2017, these shares were cancelled and converted into the right to receive 40,614 class A ordinary shares of Parent and a cash payment for fractional shares pursuant to the Merger Agreement.
- (2) Pursuant to the Merger Agreement, these Performance-Based Restricted Stock Units were canceled and converted into the right to receive 174,716 class A ordinary shares of Parent and a cash payment for fractional shares pursuant to the Merger Agreement.
