Item 2.01. Completion of Acquisition or Disposition of Assets

On July 22, 2009, the Company completed the acquisition of the Genco Commodus, a 170,500 dwt Capesize newbuilding. The Company had agreed to buy the vessel under the terms of agreements that the Company entered into with companies within the Metrostar Management Corporation group to acquire nine Capesize vessels as previously announced on July 18, 2007. The Genco Commodus is the seventh vessel to be delivered to the Company under such agreements. The Company paid a total purchase price of approximately \$120 million for the Genco Commodus, which the Company financed with borrowings under its 2007 credit facility. The Genco Commodus is expected to be delivered to its charterer, Morgan Stanley Capital Group Inc., on or about July 23, 2009 to commence a time charter for 23 to 25 months at a gross rate of \$36,000 per day, less a 5% third party brokerage commission.
