Subject to earlier forfeiture under certain circumstances, the RSUs vest as to one-third of the 1,400 RSU award on November 22, 2011, November 22, 2012, and November 22, 2013. On the November 22, 2011 vesting date RSUs were settled for 466 shares of common stock, of which 148 shares were withheld to pay taxes applicable to such settlement. The Fair Market Value of the shares withheld to pay taxes was determined to be \$62.44 per share as of that date, which was the closing price for the common stock on NYSE Amex Equities.

- (i) cash equal to the per share Fair Market Value of common stock on the vesting date times the number of shares underlying the RSUs
