Press release issued January 29, 2007 in which the Registrant announced that the final assay results from the 2006 core drill program at the Registrant's new Mitchell gold-copper deposit have confirmed (i) a sizeable mineralized zone with notable continuity, (ii) northern and eastern limits to the deposit and (iii) potential for significant expansion to the south and southwest. The Mitchell deposit is located on the Registrant's 100% owned Kerr-Sulphurets project near Stewart, British Columbia. An independent resource calculation is now in progress for the Mitchell, Kerr and Sulphurets deposits, compliant with National Instrument 43-101.
