### Item 3. Source and Amount of Funds or Other Consideration

The source of funds for the purchases of the Common Stock (as defined above in Item 1) was working capital of UBS AG and the affiliates that purchased the subject securities.

The shares of Common Stock were transferred to UBS Portfolio LLC, an entity wholly owned by UBS AG, for investment and propriety trading purposes (but not with the purpose or effect of changing or influencing control of Regency Centers Corporation). Except as otherwise described herein, none of the reporting persons has any plans or proposals relating to or which would result in any of the transactions described in Items 4(a) - (j) of Schedule 13D.

### Item 5. Interest in Securities of the Issuer

As of the date of the event requiring the filing of this schedule, UBS AG beneficially owns (but disclaims such beneficial ownership) 4,234,008 shares of Common Stock of Regency Centers Corporation, or 7.07% of the class outstanding, as reported in the New York Times on February 11, 2004.

To the best knowledge of UBS AG, no contracts, arrangements, understandings or relationships (legal or otherwise) exist UBS AG and any other person with respect to the securities of the Issuer.
