This Registration Statement registers additional shares of the Common Stock of Intevac, Inc. (the *Registrant*) to be issued pursuant to the Registrant's 2004 Equity Incentive Plan. - (3) To remove from registration by means of a post-effective amendment any of the securities being registered which remain unsold at the termination of the Registrant's 2004 Equity Incentive Plan.
