Item 1.01 Entry into a Material Definitive Agreement.

On October 17, 2006, Technical Olympic USA, Inc. (the <u>Company</u>), certain subsidiaries of the Company party thereto as guarantors (the <u>Guarantors</u>), the lenders party thereto (the <u>Len</u>ders), the financial institution party thereto as issuer (the <u>Issuer</u>) and Citigroup North America, Inc. as agent for the lenders and the issuer (the <u>Administrative Agent</u>), entered into a Limited Waiver Agreement (the <u>Consent</u>). The Consent permitted interim borrowings and provided until October 25, 2006 for the Company to prepare and negotiate an amendment to the Credit Agreement, dated as of March 9, 2006 among the Company, the Lenders, the Issuer and the Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the <u>Credit Agreement</u>) which would modify the Borrowing Base and availability under the Credit Agreement and provide collateral by the Company and its subsidiaries to secure their respective obligations under the Credit Agreement and the other loan documents.

On October 23, 2006, the Company, the Guarantors, the Lenders, the Issuer and the Administrative Agent entered into Amendment No. 1 to the Credit Agreement (the <u>Amendment</u>) to, among other things, modify the Borrowing Base and provide such collateral.

The foregoing descriptions of the Consent and Amendment do not purport to be complete and are qualified in their entirety by reference to the full text of such Consent and Amendment, a copy of which is filed as Exhibits 10.1 and 10.2, respectively, to this Current Report on Form 8-K and is incorporated herein by reference thereto.
